85 MILE TORNADO KILLS 1, INJURES DOZENS

According to the National Weather Service, the tornado that tracked across several counties in Wisconsin was the longest in terms of continuous damage ever recorded in Wisconsin.

While there have been deadlier tornadoes recorded, in Colfax and the 1899 F5 in New Richmond that killed over 100, this storm was graded an EF3 with winds of 140mph.

The storm track from start to finish was along and just south of US Highway 8, beginning in far southeast Polk County and ending east of Conrath, along the Price/Taylor County line.

The storm began as an EFO, then increased in

strength as it tracked eastward, reaching EF3 levels north of Chetek, then weakening somewhat as it continued eastward.

Within moments of the winds and storms ending, chainsaws could be heard throughout the damage area, not much later, the Red Cross, and many local agencies set up shop to help victims of the tornado.

Among the groups stepping up to help was the RANWW Foundation. Partnering with the Indianhead Community Action Agency, our Foundation provided several thousand dollars to help victims with expenses and emergency housing as cleanup contin-

ues. Agencies and hundreds of volunteers have been clearing brush and downed trees, providing food and other resources for those affected. Wisconsin Emergency Management and the Wisconsin National Guard, along with several local emergency management agencies have all been involved in cleanup.

Campgrounds were particularly hard hit, just in front of their busy season, many will remain closed for the year as damage is assessed.

Banks in Barron and Rusk Counties are set up to take donations or you can contact the Red Cross.

Lenz was elected to the bench in April of 1994.

ODDS & ENDS

Stanley Mayor Mike Henke for the past 5 years resigned last month. His last day was May 11.

The second WRA Call To Action on increases to K-12 education and property tax relief was sent to all members on May 30th. It only takes a few seconds to answer the call. All RANWW members are strongly encouraged to respond to the call as soon as possible.

The St. Croix Meadows Greyhound track has sat empty since it closed in 2001. A developer wants to make an investment of nearly \$200 million to the site. In three phases, the developer would build a stadium and baseball field for a Northwoods League team. Next, a brewery, hotel and other restaurants. Office space would utilize the existing building. Stores, additional offices and condos would make up phase three of the project which, if approved, would begin later this year and be completed in 2021.

SAND MINE & PROCESSOR APPROVED

A sand processing facility that would take 16 acres of wetlands in northern Monroe County to process and ship frac sand from a mine in Jackson County received approval from the Wisconsin Department of Natural Resources.

As part of the agreement, which still needs approval from the Army Corps of Engineers, the company will protect 643 acres of wetlands. The DNR notes that this is the first time wetland preservation is being used to preserve parts of the same wetland. The fact that the company wants to preserve over 640 acres and only use 16 was part of the reason the DNR approved the plan. The project will cost over \$65 million and will employ over 100 people.

The Corps decision will come sometime this summer.

The Jackson County Board of Adjustment approved a second sand screener for Taylor Frac. They will add dust collectors when they receive DNR permits for their increased sand storage.

MONDOVI DEVELOPER FACES ACTION FROM CITY

The City of Mondovi has filed a lawsuit against North Creek Developers for \$500,000 over the developers failure to reimburse the city for improvements made in a city TIF district.

TIF 2 was developed by the city in August of 2005 to be used as residential or industrial development, later that year, the three members of North Creek Developers bought 40 acres in the TIF with the intention of developing single family housing. With 63 lots to work with, the developer only constructed eight homes and four duplexes within the TIF with a guaranteed value of each home at a minimum of \$175,000.

The developer agreed to the city that the development would generate more than enough tax to pay back the \$1.5 million investment the city made in infrastructure costs, also homes within the TIF were valued at less than the promised \$175,000.

The city states that the current amount owed to the city is \$515,788 plus interest and attorney fees.

There is no court date yet, and the developer has until the end of June to respond to the charges.

Mondovi Park Board is working on a number of concepts to improve their Mirror Lake Park facilities.


The park board is working with engineers to determine if the pavilion at Mirror Lake park can be moved to a different location, and if so, what kind of design that building would look like. Discussion

surrounded having bathrooms, but also having hookups to put a sink, countertops and power.

Of concern to the neighbors across the street was where the building would go, and who would have a diminished view of the lake.

If a new structure is built with bathrooms, the DNR would need to be involved. If a design for the pavilion can be reached, it could be put out to bid this fall and be ready next summer.

Aging playground equipment was also a target of discussion as was the depth of the lake, which in many parts, was only one to three feet deep and has algae blooms in the summer months.



The proposed 2017-19 state budget would end the state portion of the property tax levy, thereby permanently lowering property taxes by approximately \$90 million per year. The state forestry tax, which increases each time a property's value increases, would no longer be imposed on Wisconsin property owners.

Background:

The governor's budget removes funding for the state forestry program from the property tax and replaces it with general purpose revenues in the amount of \$180 million over two years to ensure continued funding for the important forestry program.

The new funding will protect state payments to the forestry account in the conservation fund.

Ending the state-levied property tax will save the median value homeowner approximately \$27 per year today and more in the future as home values increase.

What's in play:

Proposal: The WRA supports the elimination of the state forestry property tax and will work with the legislature to see this proposal signed into law with the passage of the state budget later this year.

Bill status:

Introduced.

MY THOUGHTS—BY BRUCE KING

I've been a trained storm chaser for 40 years now. From short lived tornadoes to the July 15, 1980 windstorm, I've chased them, reported on them, and shot video of them. When my daughter called me on May 16th, asking me if I knew what was happening in Barron County, I had just returned to my hotel in Washington DC for the start of NARs Legislative meetings.

I started accessing information on my phone, and watching coverage of what was happening. I fired off texts to John Flor and Dan Lawler, who were there with

me, letting them know and asking them if they have listings in the affected area. The next morning, I was with Stacey McKinney and Brenda Barnhardt, who put the Foundation to work, providing thousands of dollars for those affected by the storm with emergency housing expenses.

I've seen a lot in my years of chasing storms, but a tornado with a track of over 80 miles is one for the history books. It should also give you pause to have an emergency plan in place where you live and also where you work. As was evidenced from Bar-

ron to north of Chetek, Cameron and on to Conrath, a tornado can change your life in a matter of seconds, planning ahead by keeping important documents in one place, and a backup set in a safety deposit box at the bank are good starts, backing up your computer and keeping that in an off site location is also a good way to retrieve what you need in case disaster strikes.

As the cleanup continues and families start to rebuild, reach out to local organizations and find ways for you to lend a hand, drop off clothes or make a cash donation.
