CANDIDATE FORUMS IN EAU CLAIRE

Voters in Eau Claire will have two opportunities to listen to candidates and incumbents for public office at forums held this month.

The first will be held for the candidates running for Eau Claire School Board. There are four seats up for

election. The regular three seats plus a seat that was filled last year due to a resignation during the term. That seat was filled and must run for a full term on the board. The school board forum will be on March 8th at 7pm at CVTC on Clairemont Avenue. The

candidates running for Eau Claire City Council will meet one week later on March 15th at 7pm. There are four contested races for five seats plus REALTOR® Terry Weld will run for a full three year term on the council as he was appointed to a vacancy last year.

ODDS & ENDS

The spring election is Tuesday, April 3rd. Be sure you learn all you can about the candidates and their positions before voting.

The fall primary election is Tuesday, August 14th.
Chances are, you'll be going to the polls on both of these dates.

There are now six announced candidates for Congressman Sean Duffy's 7th Congressional seat, there are two Democrats challenging freshman 92nd District representative and Mondovi Mayor Trig Pronschinske, and over a dozen announced Democrats running for Governor Scott Walkers seat.

There is a full slate of candidates for the available seats on the Eau Claire School Board and four of five district seats on the Eau Claire City Council are contested plus a special at large election featuring incumbent REAL-TOR® Terry Weld.

Senate Bill 727 Fails To Advance

Last month, we told you about Senate Bill 727, which gives taxing authority for the City of Superior or the City of Eau Claire to establish an exposition district.

The community of Superior is solidly behind this effort. Is a referendum last year, 82 percent of eligible voters turned out and the referendum passed with over 75 per-

cent in the affirmative.

However, after the Eau Claire Chamber of Commerce publicly supported the bill, it withdrew its support effectively killing the measure in the Legislature

An exposition district uses a tax up to two percent in the district on hotels, food an beverage to offset development cost, most of that will be borne by the developers of the project, who will bring in substantial investment dollars to develop the district. Now, the bill returns to the shelf to be brought back after the new session of the Legislatures begins on January 7th. The Chamber wants to set up a task force to make the plan more acceptable for its membership.

HOME REPAIR FUNDS ARE AVAILABLE

Housing rehabilitation funds are available to qualifying homeowners to assist in repairs such as roofing, siding, wells, septics, heating, electrical, windows, doors, sewer and water laterals, and handicapped accessibility modifications. Funds are in the form of a zero percent interest, deferred payment loan, secured by a mortgage. The property must be titled in the owner's name, property taxes current, and the property insured. Landlords with qualifying rental units can access zero percent interest loans amortized up to 10 years. Applicants must fall at or below certain income limits based on household size.

The Northwest Regional Planning Commission, based in Spooner, is administering the program which represents the counties of Ashland, Bayfield, Burnett, Douglas, Iron, Price, Rusk, Sawyer, Taylor, and Washburn. EAU CLAIRE AT THE STATE SUPREME COURT

A number of taxpayers associated with a group called Voters With Facts, who have lost a number of cases relating to the city of Eau Claire using TIF financing for the Confluence Arts Center, have their day in front of the Wisconsin Supreme Court.

The group says that a \$1.5 million cash payment to a developer violated the state Uniformity clause, which requires all property in the jurisdiction to be treated

equally. Wisconsin Attorney General Brad Schimel is supporting the city's assertion that it acted properly when advancing the funds.

The group also questioned whether the site the new arts center is being constructed was actually blighted, which is a condition normally of a TIF district to corrent. The group says it isn't,

the city disagrees. The Wisconsin Supreme Court has a track record of decisions that affirm the constitutionality of TIFs. Both the circuit court and court of appeals have upheld Eau Claire's position.

The court will review both sides of the issue and is expected to issue a ruling deciding the matter or sending it back to a lower court sometime this summer.

SHORTAGES IN FRAC SAND CONCERN DRILLERS

A report by *OilPrice.com* suggests from oil industry leaders that the current shale oil boom may be hampered by supply issues from transportation to a frac sand shortage.

RANWW, in its territorial jurisdiction has more than three quarters of all frac sand mines and processors in Wisconsin. Slowly, idled mines are coming back online, while others that weathered the shale downturn with small crews and now roaring back to full production. Area newspapers are constantly advertising for needed employees and mines that produce the much desired Northern White sand, namely for its size and hardness, are again in demand. However, costs associated with getting the

proppant to Texas via rain adds to the costs of drilling, so miners in Texas have turned to Texas brown sand, which does not work as well, but is readily available and costs less to obtain. In 2012, 34 million tons of sand were used in wells, by the end of the year, its expected that over 100 million tons of sand will be used, and that may not be enough to meet demand.
