1008 GORDY'S EMPLOYEES MAY LOSE JOBS

The troubles began months ago. Little by little, shelves in all 25 of Gordy's Markets stopped being restocked. Little by little, deliveries stopped coming to the stores, little by little, the management announced they had to close stores and move their scant inventory to other stores to try to shore the stores that were operating.

Then came the sale to Festival Foods of its stores in Tomah, and West Clairemont and Birch Street in Eau Claire.

Then came legal action filed in Chippewa County court by their supplier, Spartan Nash from Michigan that Gordy's owed them nearly \$86 million and had no prospects or ability to repay such a large amount.

The remaining stores were placed into receivership in hopes that something good would come of it all.

The announcement that followed was felt statewide. Unless it can find a buyer or multiple buyers for its remaining stores and the ones that are closed, Gordy's will be forced to layoff employees.

All 1008 of them by October 28th.

The layoff notice was made by the Wisconsin Department of Workforce Development, and affects every Gordy's location with the exception of Osseo. In Eau Claire, with the former Mega East location still empty (a facility bought out by Gordy's) and now the Hamilton Avenue site empty, at least temporarily, there is some hope for the Schaffer family.

In addition to Festival converting the two Eau Claire stores and one in Tomah, Randy's Neighborhood Markets, an Iowa based chain of stores is looking to buy the Galesville location, and Hansen's IGA in Bangor may be in negotiations to purchase Gordy's Black River Falls location, as they have applied for Gordy's liquor license.

The Bayfield County Board voted to invest \$11,250 toward a study that look at a potential \$48 million renovation and remodel of the Telemark Resort.

A group called HK Hospitality Management is working with National Bank and Commerce to arrange financing and develop a plan to reopen the lodge which has seen many owners, and many bankruptcies over the last decade.


Plans include a full renovation of the rooms, 20,000 square foot conference cen-

ter, golf course and ski hill. The study will look at not only costs for the renovation, but the expected costs to maintain the facilities and be able to attract customers to its lodge and conference facilities on a year-round basis.

More Democrats Announce For Governor

Both Superintendent of Public Instruction and Eau Claire attorney and 91st Assembly incumbent Dana Wachs have announced that they will seek the Democratic nomination for Governor next year.

Expected to add to that growing list of contenders is Mike McCabe, who has been involved in politics for many years in Wisconsin and grew up in Clark County.

Both Evers and Wachs are no strangers to elections, but Evers has experience in statewide elections.

Last month, we reported that Senator Kathleen Vinehout amended her campaign finance statement to be able to raise money for a possible run for Governor. Other candidates are likely to join this already crowded field in the weeks and months to come.

Governor Walker is expected to formally announce his run for a third term as soon as the budget is done and passed by the Legislature.

RANDALL PARK & WATER STREET COULD GET TIF DISTRICT

The Randall Park neighborhood and Water Street businesses could be part of a new TIF district in Eau Claire.

TIF #12, that would help with development in the Water Street area and the Randall Park neighborhood will go before the Plan Commission and City Council this month.

The TIF would be in place for 20 years and could help

with new construction, remodeling and other projects in the area. The funds could also be used to extend the bike trail to the Chippewa River behind the Sonnentag Events center that will begin construction in the next year on Menomonie Street.

The Randall Park neighborhood is the subject of project development and funding by the Invest Health Eau Claire project, funded in part by the Reinvestment Fund of the Robert Wood Johnson Foundation.

The 18 month project to identify need and costs for renovation, replacement and other determinates of health in the neighborhood will conclude early next year with financing and an action plan for implementation.

TOWN OF ALMA APPROVES MINING AGREEMENT

Wisconsin Proppants and the Jackson County Town of Alma agreed to a formal agreement on mining in the town, and a road use agreement.

Not everyone was in favor of the agreement. Two separate petitions were circulated, with over 120 citizens opposed to mining in the township and a second with 187 signatures in favor of mining.

Those opposed to mining



cited dust, water pollution, well protection and noise from trucks and the operation itself.

The mining company will be allowed to construct a berm around the facility in stages instead of all at once and have reached an intergovernmental agreement with their neighbor to the east in Clark County for road use,
