MLS Photo Resolution Upgrade

Cotality has confirmed an upcoming upgrade to NWWMLS listing photos, increasing resolution from **1024 × 768 pixels** to **2048 × 1536 pixels**.

The higher photo resolution will apply to new listings and newly uploaded photos only. Existing photos will not automatically be converted. Photo rules and requirements remain unchanged.



Rescheduling a Projected Closing Date in Matrix

If a closing date is rescheduled, the **Projected Closing Date** must be updated in the MLS as soon as the change is known. Listings in both **Active Offer (A/O)** and **Pending** status require a **Projected Closing Date**.

How to Update the Projected Closing Date:

1. From **My Matrix**, go to **My Listings**.
 - Select **My Active Listings** if the listing is in **Active Offer (A/O)** status.
 - Select **My Pending Listings** if the listing is in **Pending** status.
1. Locate the listing that needs to be updated.
2. Check the box next to the listing.
3. Click **Edit**.
4. Select the appropriate **Change Status** option based on the listing's current status
5. (*Change to Active Offer or Change to Pending*).
6. Update the **Projected Closing Date** to the new, correct date.
7. Click **Submit Listing** to save the changes.

Reminder

All listing status changes must be entered within **three (3) business days**, per MLS policy. Keeping the Projected Closing Date current helps prevent late status warnings and potential fines.

Tax Increment Financing (TIF)

Tax Increment Financing (TIF) is being used by cities across the U.S. to fund affordable housing, downtown revitalization, transit, and walkable urban development, with notable successes in places like Muskegon, Milwaukee, Carmel, and Washington, D.C.. While TIF can spur economic growth and community improvements, its use for large-scale projects like data centers has drawn criticism for potential risks, lack of transparency, and questionable public benefit. When applied responsibly, TIF and related value capture tools can transform blighted areas, support mixed-use development, and generate lasting fiscal benefits for municipalities.

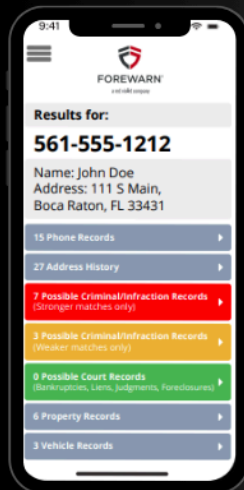
