



MLS **Message of the Day** pops up for viewing anytime a new post occurs since the last time you logged in. It is always available for view/print from **Message of** the Day link on the MLXchange Home Page, just above Resources on the right side of the screen.



Emails are sent to members on a regular basis. If you are not receiving them, be sure the 1) the RANWW or MLS has your current email address, 2) check your Junkmail folder, 3) add RANWW staff email addresses to your address book. RANWW or MLS will almost always appear in the Subject line for easy identification.

MLS Update

The **Lockbox Conversion** is history and after 2 full months of long, sometimes dirty days (12 accumulated years of dust, dirt, wind, bugs, etc makes for some pretty filthy equipment, as you well know) RANWW/MLS staff can truly say they are a "little tired of lockboxes!" We thank each of you for your cooperation, patience and kind words during the conversion process!

The MLS Committee recommends the use of an **Electronic Lockbox** on all properties to ensure security of the seller's property.

Members are reminded that any **Virtual Tour** published through the MLS must be "unbranded." Present policy allows for the company logo only—no name, contact information, agent photo, etc.

Two new data fields, **Electronic Signature Y/N** and **Electronic Delivery Y/N** will soon appear in the MLS, both under listing/maintenance and on the full display. Watch for further details in upcoming MLS Messages of the Day, emails, newsletters, etc. (see Pg 2 for brief description)

Appraisers and Realtors® alike will be pleased to know the **Seller Concession text field** will soon be on the Full Display making that information more readily available to all members relying on MLS data for comparable purposes.

Realtorcomplaints.com Scam

NAR has received several inquiries about the website http://www.realtor-complaints.com/. NAR quickly responded with this blog http://speakingofrealestate.blogs.realtor.org/2013/01/10/don%E2%80%99t-let-your-reputation%E2%80%94or-your-wallet%E2%80%94fall-prey-to-scam-complaint-site/

NAR sent a cease and desist letter to the site operator regarding their unauthorized use of the Realtor® trademarks. Since the site operators are likely located in Africa, obtaining their compliance may be challenging. NAR also initiated complaints with PayPal regarding the site and sent a note to PayPal's fraud division.

If you receive emails from alleged consumers telling you there is a complaint about you *on this site*, NAR would like to collect those emails. If you have such emails please send them to Debbi Conrad @ dconrad@wsra.org WRA will compile them and forward the information to NAR.
