10TH SENATE SPECIAL ELECTION JANUARY 16TH

The field is set after primaries on December 19th cut the field for Democratic and Republican candidates to compete for Sheila Harsdorf's 10th Senate seat.

28th district Representative Adam Jarchow survived a challenge from fellow state Representative Shannon Zimmerman of River Falls.

On the Democratic ticket, St. Croix County medical examiner Patty Schactner defeated two opponents while Libertarian candidate Brian Corriea was unopposed.

The three will be on the January 16th special election ballot. The winner of the election will fill the un-

expired term of Harsdorf, who resigned to take a job as Secretary of the Wisconsin Department of Agriculture, Trade and Consumer Protection.

Should Jarchow win election, he would have to resign his seat in the state Assembly. With 2018 being an election year and the Legislature due to wrap up its business in February or early March, it is unclear whether Governor Walker will call a special election for this spring's election in April, or leave the seat empty until the fall election in November when all Assembly seats and half the state Senate are up.

WRA has publically en-

dorsed Jarchow for election to the seat. Campaigning will be fast and furious as the candidates only have three weeks to get their message out.

The 10th Senate district covers parts of Polk, St. Croix, Pierce and Dunn counties. The GOP is active in trying to keep the seat while Democrats see an opportunity for a pickup and a narrowing of the Republican advantage in the upper house. They also see results from special elections across the country that have gone Democratic in the last three months. Both parties will be going all out in the days ahead of the special election on January 16th.

4 SEATS UP ON EAU CLAIRE SCHOOL BOARD

It's unusual that a majority of seats would be up on any school board. Incumbents Joe Luginbill, Lori Bica and Eric Torres are up for re-election and all three are running. Kathryn Duax is not running for re-election as she is moving to Texas to be with family.

The reason for four seats being up at the same time is that both Torres and Bica's seats were appointed to fill unexpired terms, now they have to run for a full three year term.

In Altoona, there is only

Mike Hilger's seat on the school board. In Chippewa Falls, Pat Allen and Staish Buchner are up for re-election, while in Menomonie, three seats for Urs Haltinner, Penny Burstad and James Swanson are up on the Menomonie School Board.

CONTESTED RACES FOR EAU CLAIRE CITY COUNCIL

It doesn't happen too often, but this year, there will be contested races for district seat on the Eau Claire City Council. All five incumbents, Dave Klinkhammer, Kathy Mitchell, Tim Tewalt, Andrew Werthmann and Bob Von Haden are running. At large member Terry Weld, REALTOR® at Donnellan Real Estate in Eau Claire is running. He was appointed to fill the unexpired term of Eric Larsen who left to work with the Eau Claire Police depart-

ment as a consultant. Weld needs to run for the balance of Larsen's term.

Two of the district's seats will be contested. Kathy Mitchell's seat will be opposed by Jeremy Grangert in District 3. Jeremy is involved with the Third Ward neighborhood and serves on many committees particularly with increasing access to bike trails around the city

and sits on the Montessori governance board. In District 1, Emily Berge will oppose Tim Tewalt. Berge is a licensed councilor and says she is concerned with the lack of community involvement with regards to decisions made by the council.

5pm Tuesday January 2nd is the deadline to file for the spring election to be held on Tuesday, April 3rd.

There will be a candidate forum for the 10th Senate District special election on Thursday, January 9th at the Dunn County Judicial Center beginning at 6:30pm.

GREGG MOORE NOT RUNNING AGAIN

Eau Claire County board chairman Gregg Moore announced that he will not seek re-election to his county board seat. Moore has been county board chair for over a decade. He is one of four county board members that will not seek re-election. Others are Kathleen Clark, who represents the west side

of Eau Claire for the past 26 years will not run again. Mark Olson was appointed to his District 25 seat in 2013 and has been re-elected for two terms will not run again for his northside Eau Claire seat. And Katy Forsythe, who represents District 6 in the Fall Creek area for the past 3 years will be done in April. In addition to

chairing the county board, Moore has been the chairman of the Wisconsin Counties Association for the past two years.

Anyone wanting to run for a county board seat needs to file nomination papers with 100 to 200 signatures and have them in to the county clerk by 5pm January 2nd.

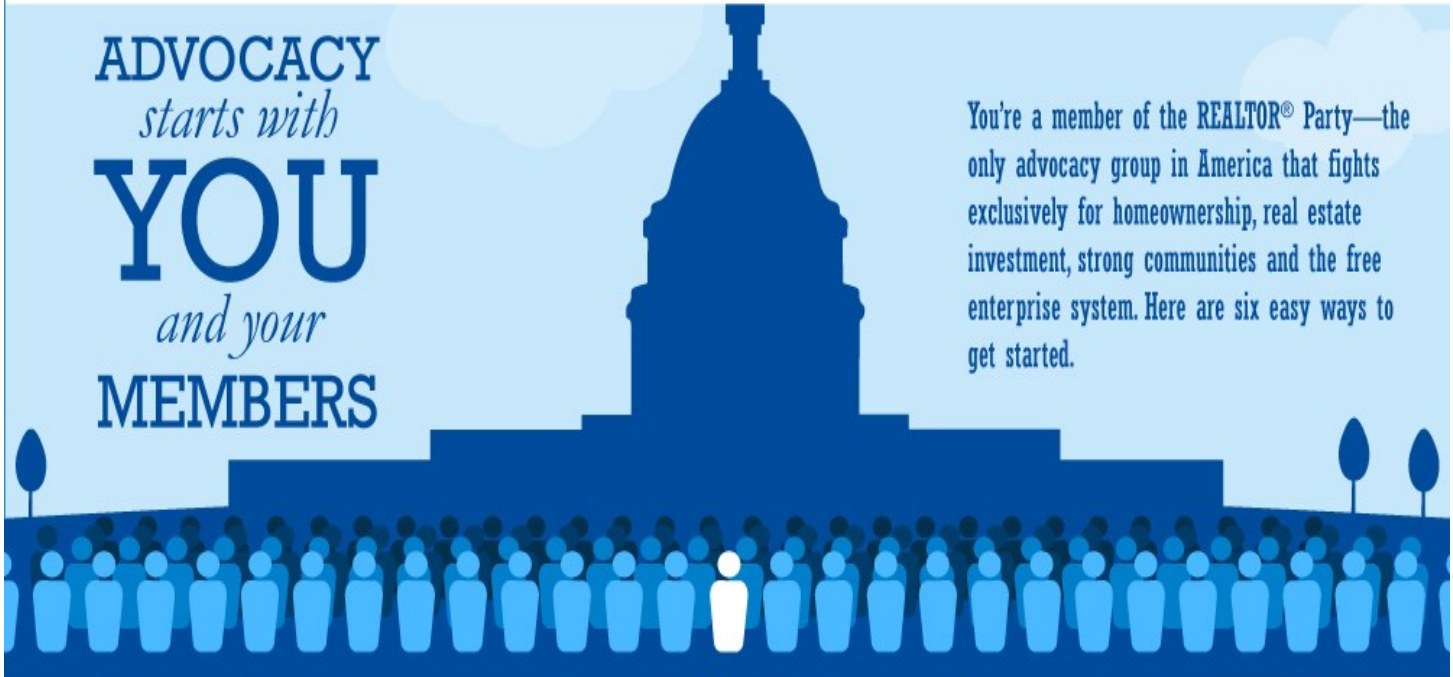

CHIPPEWA FALLS SCHOOLS SETS \$65 MILLION REFERENDUM

The Chippewa Falls school district will put a \$65 million referendum on the spring ballot. The action was approved by the school board on a 6 to 1 vote.

Items included in the request include a new Stillson Elementary school, adding a classroom addition, technology improvements, middle school renovations and im-

provements, various capital improvement projects thru the district, and a science, technology, engineering, arts and mathematics lab as well as technology upgrades to the high school.

The new Stillson Elementary site is on County highway I on 19 acres that the district owns.

If the referendum is ap-

proved, the impact on a \$100,000 home would be \$125 a year for the next 22 years.

A new state law also restricts the times a school district can go before the public for referendum request. It is limited to regularly scheduled spring and fall election cycles.

FORMER HUEBSCH PROPERTY TO BE APARTMENTS

The former business location on the Eau Claire River was first going to be saved and used as a mixed use building, but plans for the century old building were scrapped when costs to renovate the building exceeded tearing it down and building something new.

That something new was going to be upscale condos with underground parking and four buildings on a compact site. Those plans have

been abandoned, but the site hasn't. The 101 will now be the site of 146 market-rate apartments in one building with commercial space on the first floor and four floors of apartments in studio, one and two bedroom sizes. One of the advantages to building next to the river is that a canoe launch will be constructed below the apartment building that will have easy access to

the Chippewa River two blocks away.

This is not the only project that JCap Real Estate is involved in downtown. The company is currently renovating the former six story Wells Fargo building near the Confluence Art Center with commercial space on the first and second floors with 25 luxury apartments on the four upper floors. That project will be done in May 2018.

CANNERY DISTRICT TO GET NEW PARK

The Cannery District continues to gain land and is poised to start development. When the design of the district was undertaken, amenities such as a park and a bike trail that would connect downtown with other parts of the existing bike trail was a priority.

Armed with a \$16,500 grant from the National Association of REALTORS® &

your Association, an engineering study for the new bike trail was undertaken. That trail was finished this fall. The trail will intersect the new park, which the city's Redevelopment authority purchased the existing Kessler Park at 2300 1st Avenue with plans to redevelop the existing park and build a new park in its place in the Cannery

District. The park and surrounding area already has green spaces built into the design.

Most of the land for development has been purchased with the exception of three parcels in the vicinity of the Eau Claire Children's Theater and Kwik Trip that are on the far south end of the district.

POLITICAL ODDS & ENDS

At least two openings will occur on the Whitehall City Council as Mayor Dan Schreiner and Councilperson Deanna Matthews are not running for re-election.

RANWW member Dave Masterjohn is running unopposed for re-election to the

Washburn County Board. Masterjohn represents District 12.

Joshua Eggleston, city administrator in Durand, resigned his post effective February 2nd. Eggleston and his wife are moving to Michigan to be close to his elderly parents.

North Creek Developers and the City of Mondovi have been involved in a lawsuit over the development of land on the city's northeast side. The settlement involves surrender of 33 lots to the city of Mondovi with a value of \$660,000. The controversy has been ongoing for over ten year and is now closed.

First, a HUGE THANK YOU to our 950 members and affiliates for being members of RANWW.

Next, thanks to over 300 of our members, your Association set a record for RPAC investments, this year passing the \$50,000 mark.

Now, here's a preview of what's to come in 2018:

—2018 will be known as “A Year of Action”. As you first learned in this column last month, RPAC investment will start early, January 2nd with a rollout of a month-long recruitment program for the Large Donor Council. It's an investment of \$85 a

month, billed to your credit or debit card each month and renewed in November each year. It's a way to become an LDC (you receive the perks on day one, not when its all paid). Your Association is one of the top 3 in LDC membership in the state for three years in a row, this is a way to get more members & affiliates involved at a higher level and provide a budget-friendly way to do it instead of coming up with \$1000 at once. Our goal is to have 50 LDC members in 2018.

Our budget for next year is \$50,000, with 50 LDCs, well you see why the goal is

what it is. Political season is already in full swing with a special election in mid-January for the 10th Senate district. Spring elections are on tap for April 3rd, then we transition to the fall election cycle where we elect a Governor, Attorney General, all 99 Assembly seats and half the Senate, including 3 Senators in our Association. We have two open legislative seats now, and there may be others as incumbents decide not to run again.

REALTOR® & Government Day in February 7th, we need a large contingent to be in Madison. I'll see you there.
