#### SPRING ELECTION 2022: SCHOOL BOARDS

The Eau Claire school board will see a total of six candidates for three open seats on its board. Incumbents Tim Nordin and Marquell Johnson are running for re-election. Aaron Harder is not running for re-election.

The other candidates running for three-year terms on the board are Melissa Winter, Stephanie Farrar, Nicole Everson and Josh Ingersoll.

In Chippewa Falls, it's the same story. There are six people running for three open seats on the board. Two incumbents, Sherry Jasper and David Czech are running while board clerk Kathy Strecker is not running again.

The other candidates are James Ledebuhr, Den-

nis Fehr, Kate Bushman and Sarah Hanson.

In Altoona, there are three seats open and three people running. Richard Hager and Nicole Breed filed to run as did Jeremy Zook who is the only incumbent running. Dan Gluch and David Rowe are not running for another term.

In Menomonie, seven people will run for three seats. Board President David Styer is running along with Rachel Henderson, Scott Parker, Jennifer Sakry, Abraham Smith Brittany Welker and Dominique Stewart.

Chris Freeman and Clint Moses did not file to run for another three year term.

The state of Washington is joining Oregon and California in taking steps to end single-family zoning.

Housing supply has failed to keep up with growth in population because many municipalities only allow single-family homes.

The plan allows development of 50 or more residential units per acre if it is located within half mile of fixed transit, one duplex, triplex or courtyard apartment in one or more area zoned for singlefamily, and accessory dwelling units on all parcels in areas zoned for single-family housing.

### SPRING ELECTION 2022: EAU CLAIRE CITY COUNCIL AND COUNTY BOARD

Two of five incumbents to the Eau Claire City Council are running again. Kate Beaton and Roderick Jones are running. REALTOR® John Lor, Dave Klinkhammer and Catherine Emmanuelle are not running again. New candidates include Joshua Miller, Brian Trowbridge, Bob Carr, Mark Richter, Charlie Johnson and Larry Mboga are on the April 5 ballot.
